Conditions for Participation

1. Mauritian Visual Artists *
2. Artworks should be 'original'- no copy/ reproduction, executed not later than the two previous years.
3. Artworks should be submitted ready for display (with frame and appropriate fitting devices and any other relevant information). The National Art Gallery will be responsible for the display of artworks. However, in case of specific display, the collaboration of the artist would be required.
4. Paintings:
 - Format: Not exceeding A2 (59.4 x 42 cm)
 - Techniques: Participant is free to choose appropriate techniques
 - Craft works will not be considered
5. The exhibition will be held in the month of June 2018 at the Plaza, Municipality of Beau Bassin/ Rose-Hill.
6. 'Selected' artworks should be submitted at the Plaza on a specific date which will be communicated to you in due course.
7. Participants will be responsible for the transportation of their artworks to and from the venue. Artworks should **ONLY** be collected **immediately after** the closing of the exhibition at the Plaza. Additional details will be made available at a future instance.
8. Artworks will have to be insured by the participating artists themselves. NAG will take all precautionary measures for the display of artworks, but will not be responsible for any damage.
9. **Participant should submit** (EITHER by email as attachment OR by post or hand-despatched on a CD or DVD):
 - Duly filled in *Entry Form* and signed copy of the *Conditions for Participation*
 - A good quality digital photo of artwork (JPEG file at 300 dpi)
 - A passport-sized photo of yourself (JPEG file at 300 dpi)
 - A brief description of yourself or an updated C.V
10. A Committee will be set up to:
 - Examine/ select entries of first-time participants
 - Conduct an overall screening of entries of previous participants.The decision of the Jury will be final.
11. NAG has the right not to accept an artwork and is under no obligation to provide a justification for non-acceptance.
12. The National Art Gallery reserves the right to reproduce submitted materials/ artworks for publication and promotion.
13. **Deadline** for submission of entries/ applications is **Friday, 18 May 2018** by **4 p.m.** latest, **either** by
