## Conditions for Participation

1. Mauritian Visual Artists registered at the National Art Gallery\*
  2. Artworks should be 'original', executed not later than the two previous years.
  3. Artworks should be submitted ready for display (with appropriate fitting devices and any other relevant information). The National Art Gallery will be responsible for the display of artworks. However, in case of specific display, the collaboration of the artist would be required.
  4. Installation
    - Visual Artist is required to contact NAG prior to submitting a *Proposal for Installation*.
  5. The exhibition will be held by the end of November 2017 at the Plaza, Municipality of Beau Bassin/ Rose-Hill.
  6. Selected artworks should be submitted on **Thursday, 23 November 2017** from **10 a.m to 4 p.m** at the Plaza.
  7. Participants will be responsible for the transportation of their artworks to and from the venue. Artworks should be collected **after** the exhibition at the Plaza. Additional details will be communicated in due course.
  8. Artworks will have an insurance cover during the exhibition.
  9. **Participant should submit** (EITHER by email as attachment OR by post or hand-despatched on a CD or DVD):
    - Duly filled in *Entry Form* and one signed copy of the *Conditions for Participation* annex
    - A digital photo of artwork (JPEG file at 300 dpi)
    - A passport-sized photo of yourself (JPEG file at 300 dpi)
