## CONDITIONS FOR PARTICIPATION

1. **Eligibility:** Mauritian Visual Artists, registered at the Ministry of Arts and Cultural Heritage and/or National Art Gallery. Artists not yet registered are kindly requested to submit filled-in registration form along with the Entry Form.
2. **Artworks** to be submitted can be of any size, and can comprise drawings, paintings, photography, graphic/ digital images, prints, sculptures and art installations.
3. Participant may propose to a maximum of 5 artworks per entry.
4. All Artworks proposed should be 'original'.
5. The exhibition will be held from 15 to 28 May 2023 at La Citadelle.
6. Selected Artworks should be submitted ready for display (with appropriate fitting devices). Drilling, nailing and actions likely to cause direct or indirect damage to physical infrastructure of La Citadelle are strictly prohibited.
7. All artworks may be put on sale during the exhibition.
8. The Ministry of Arts and Cultural Heritage will be responsible for the display of artworks. However, in case of specific display and installations, the collaboration of the artist would be required.
9. The selected artworks shall be delivered by Tuesday 2 May 2023 at La Citadelle, Port Louis.
10. Participants will be responsible for the transportation of their artworks to and from the venue. Artworks should be collected immediately **after** the exhibition on Monday 29 May 2023.
11. The Ministry of Arts and Cultural Heritage will take all precautionary measures for the display of artworks, but **will not be responsible for any damage or loss of artwork.**
12. **Participant should submit the following:**
  - Duly completed *Entry Form* and one signed copy of the *Conditions for Participation Form*
  - A digital photo of artwork (JPEG file at 300 dpi or above)
  - Artist updated resume and CV
  - A passport-sized photo of yourself (JPEG file at 300 dpi or above)
13. The decision of the Jury will be final and irrevocable.
14. A grant of Rs 10,000 will be given to all selected artists displaying their artworks at the Mauritius Arts Expo.
15. A special online gallery will be created for the selected artists to showcase all artworks proposed along with a short biography.
16. The Ministry of Arts and Cultural Heritage/National Art Gallery have the right not to accept any artworks and is under no obligation to provide any justification for non-acceptance.
17. The Ministry of Arts and Cultural Heritage/National Art Gallery reserves the right to reproduce materials/ artworks for publication, online dissemination and promotion.

19. **Deadline** for submission of entries is **Wednesday 26 April 2023** by **15 00 hours** latest.
20. Entries should be deposited, in a sealed envelope, in the Tender Box located on the 7th Floor of the Ministry of Arts and Cultural Heritage, Renganaden Seeneevassen Building, Cnr. Pope Hennessy & Maillard Streets. Late Proposals will not be accepted.
