**II. Age Limit**

Candidates, unless already in service, should not have reached their 50<sup>th</sup> birthday by the closing date for the submission of applications.

**III. Qualifications**

**Candidates should possess:**

**A.** Cambridge Higher School Certificate or Passes in at least two subjects obtained on one certificate at the General Certificate of Education “Advanced Level”.

**B.** A Degree from a recognized institution in one of the following fields:

- (i) Architecture
- (ii) Archaeology
- (iii) Civil Engineering
- (iv) Communication and Cultural Studies
- (v) Economics
- (vi) Geography
- (vii) History
- (viii) Humanities
- (ix) Management and/or Administration

**C.** A Master’s Degree in one of the fields above from a recognised institution

**OR**

Equivalent qualifications to A, B and C above acceptable to the Board.

**Note**

Qualification at A above should have been obtained prior to qualification at B above and qualification at B above should have been obtained prior to qualification at C above. However, candidates who, as at 30 June 2008, did not possess the qualification at A above, will also be considered provided they hold –

- (a) a Cambridge School Certificate or Passes obtained on one certificate at the General Certificate of Education “Ordinary Level” either (i) in five subjects including English Language with at least Grade C in any two subjects or (ii) in six subjects including English Language with at least Grade C in any one subject or an equivalent qualification acceptable to the Board; and

- (b) a PhD or a second Master's Degree or a postgraduate diploma from a recognised institution or an equivalent qualification acceptable to the Board.

Qualification (a) under 'Note' should have been obtained prior to qualification at B and C above and at (b) under 'Note'.

#### **IV. Salary**
